Administrative History: Local 4440 of the United Steelworkers of America (USWA), District 6, in Timmins represents the production and maintenance workers in the mining industry. Its charter was issued on October 26th 1950. Since then, some mergers have occurred with locals of the region, the first being in 1983 when Local 4462 merged with Local 4440. In 1991, Local 7267 also merged with Local 4440. Beginning with the McIntyre Porcupine Mines Company in 1950, USWA Local 4440 has also represented workers at different companies such as: Pamour Porcupine Mines Ltd., Giant Yellowknife-Timmins, Royal Oak Mines, Kinross Mines, Chapleau Co-Generation Ltd., Luzenac, Custom Concrete and Porcupine Powder Company Inc. Local 4440 had its charter cancelled on June 6th 2005.

Custodial History: The USWA Local 4440 fonds was formerly part of P020 - International USWA Timmins Office fonds.

Scope and content: This fonds attests to the activities of Local 4440 from its certification until the present time. The minutes of the executive committee demonstrate the difficulties it faced and the solutions it implemented within the labor movement of the Timmins region. The minutes of the Joint Health and Safety Committees inform us of problems in the workplace and the work done addressing those problems. The mergers of other locals into Local 4440 are well documented. It provides information on how the transition was achieved. It also includes grievance files. The files on the Royal Oak Mines bankruptcy include documents describing the concerns of the Union on the measures taken by the company. The fonds also contains documents concerning the social impact Local 4440 had within the various communities of its membership.

This fonds is divided into 6 series arranged in alphabetical order. The series are: I) Administration; II) Chapleau Co-Generation; III) Giant Yellowknife Mines; IV) Luzenac; V) Pamour Porcupine Mines Ltd; VI) Royal Oak Mines.
